HUNTING CONDITIONS FOR THE HUNTER'S OWN SAFETY AND PLEASANT STAY

1. **Extreme care must be taken to prevent field fires.**
2. **Please keep our environment clean.**
3. All weapons are to be handled with the necessary respect and safety.
4. Only weapons of .243 calibers and bigger may be used with soft-nose ammunition.
5. **Any person/client/hunter using rifles and/or ammunition of Constantia Safaris, will be doing so at their own risk and Constantia Safaris will not be responsible for miss-fires, etc.**
6. **Only game clearly visible and in a good shooting position for the hunter, may be shot at.**
7. **Bow Hunters: not children under the age of 12 allowed in blinds.**
8. Guides cannot be held responsible for the hunter shooting the incorrect specie or sex of game. **It remains the responsibility of the hunter to ensure that the game being aimed at is suitable to his needs.**
9. Following every shot fired, the hunter must assure that the animal is not wounded. Hunters will be responsible if wounded animals been found after hunt.
10. If an animal is wounded, tracking, and killing of this animal must begin immediately. If the animal is not found after 2 hours, tracking will stop. The hunter is responsible for the **full** payment of the animal whether found or not, at the price indicated on the price list.
11. The owner reserves the right to decide how many, and which species of game may be hunted.
12. Game **not** appearing on the price list, **may not** be hunted, unless arranged with the owner.
13. Birds and other wild animals may not be killed or frightened and trees are not to be damaged.
14. No hunting will be allowed without a guide.
15. Any problems regarding the guides or accommodation must be taken up directly with the owner.
16. Any tips or other gifts may only be given via the owner to guides on departure.
17. **Any person who gives any kind of liquor to any worker OR tries to bribe a worker, will be asked to leave the property immediately!!!**
18. **Any Person under the influence of alcohol, or any other narcotic, will not be allowed to hunt.**
19. Constantia Safaris reserves the right to admission.
20. No pets. (Dogs, cats, ect.)
21. Any person who is found guilty of any of the above points will be held responsible for any claim that may occur due to their own irresponsible behavior.
22. **Constantia Safaris reserves the right to erase any sensitive footage, and to use any footage, photos, or any other video material of hunters for marketing purposes.**
23. **Hunters and other visitors to the farm, do so at their own risk. The owner does not accept responsibility for any loss, injury, death, or any other consequence, be it an accident, theft, or any other cause, when visiting the farm.**
